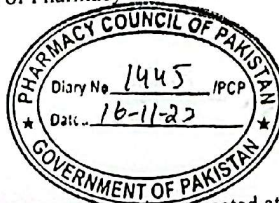

2. It is to inform that the team of Pharmacy Council of Pakistan, Islamabad visited your University on October 22, 2023 to verify the required facilities for grant of NOC of Pharm.D Program.

3. The Council considered your report in its 60th meeting held on November 13, 2023 and unanimously approved one hundred (100) seats of Pharm D Program per annum as per duly approved criteria of Pharmacy Council of Pakistan, Islamabad.

Terms & Conditions:

- i. The Institute/college/university can be inspected at any time with or without prior notice to evaluate the compliance status. In case of failure to compliance/ adherence may lead to withdrawal of recognition or any other penalty approved by the Council.
- ii. The Institute will ensure the "Enrollment of Students" within 60 days of admissions and the Institute/college/university will inform the Council regarding announcement of admissions with copies of relevant advertisement. Once enrolled, no deletion/ alteration in the enrollment of students is allowed.
- iii. The all such universities imparting postgraduate education and having Department of Pharmacy are directed to up-grade to Faculty of Pharmacy on priority basis and improve their faculty as per Councils' notification and ensure student teacher ratio (1:10). All the appointments of the teaching faculty will be as per (Qualification for Appointment of Teachers) Regulations 2015 duly notified by the Council. All employees, whether temporary/ permanent or visiting are employed on a written agreement stating salary and the terms and condition on which they are engaged. The Institute will immediately inform to the Council of any change (addition or deletion) in the teaching faculty as well as the position of the Principal or HOD or Dean.
- iv. The institute/college/university will admit the students once a year as per their approved allocation strength by the Council and will not exceed. If the Council observes non-compliance/ non-adherence may lead to withdrawal of NOC/Approval or any other penalty approved by the Council.

- v. The recognition of the Pharm. D Program will be reserved only if all the conditions notified by the Pharmacy Council of Pakistan are adhered to.
- vi. The Institute/college/university will immediately inform any change/modification in the physical facilities and in case of shifting the facility, the Institute will immediately inform and seek fresh approval for new premises.
- vii. The Institute/college/university will submit their "Clinical Pharmacy Training Program" along with the details and acceptance of such training program from the hospital.
- viii. It would be appreciated, if this Council is kept informed of the dates of the examination in pharmacy conducted by the degree awarding Institute, so that periodic assessment and evaluation of your examination system could be monitored through observers.
- ix. The Council has a legal right to revoke/withdraw the permission of admissions of Pharm.D Program if it observed any violation or non-compliance to the regulations/directions/ instructions issued by the Council from time to time.
